Consideration of a Resolution of the Commission of Knox County, Tennessee appointing _____ to serve as Judicial Magistrate for Knox County, Seat D was before the Board of Commissioners.

Upon roll call for nominations for Judicial Magistrate for Knox County, Seat D, Commissioner McKenzie passed. Commissioner Broyles was absent from the meeting. Commissioner Smith nominated Dustin Dunham. Commissioner Ownby passed. Commissioner Schoonmaker nominated Ms. Sharon Frankenberg. Commissioner Anders nominated Mr. Alexander Brown. Commissioner Busler passed. Commissioner Wright passed. Commissioner Brown nominated Michael Cabage. Commissioner Thomas nominated Ms. Rhonda Lee. Commissioner Brantley nominated Mr. Patrick Looper.

Commissioner Anders moved that the nominations cease. The following people were nominated for Judicial Magistrate for Knox County, Seat D: Mr.

Alexander Brown, Mr. Michael Cabage, Mr. Dustin Dunham, Ms. Sharon Frankenberg, Ms. Rhonda Lee and Mr. Patrick Looper.

Upon roll call vote for Judicial Magistrate for Knox County, Seat D, Commissioner McKenzie passed, Commissioner Broyles was absent from the meeting. Commissioner Smith voted for Mr. Dustin Dunham. Commissioners Ownby, Schoonmaker, Busler, Wright and Thomas voted for Ms. Sharon Frankenberg. Commissioner Anders voted for Mr. Alexander Brown. Commissioners Ownby, Schoonmaker, Anders, Busler, Wright, Thomas and Brantley voted for Ms. Sharon Frankenberg. Commissioner Brown voted for Mr. Michael Cabage.

- Ms. Sharon Frankenberg received 7 votes.
- Mr. Dustin Dunham received 1 vote.
- Mr. Michael Cabage received 1 vote.

Commissioner Wright moved to approve Resolution R-15-4-101-SS- Consideration of a Resolution of the Commission of Knox County, Tennessee appointing Ms. Sharon Frankenberg to serve as Judicial Magistrate for Knox County, Seat D. Commissioner Schoonmaker seconded the motion and upon roll call vote Commissioners Smith, Ownby, Schoonmaker, Anders, Busler, Wright, Thomas and Brantley voted aye. Commissioner Brown voted no. Commissioner McKenzie abstained from the vote. Commissioner Broyles was absent from the meeting. The motion carried 8-1-1-1.
