Consideration of a Resolution of the Commission of Knox County, Tennessee, appointing \_\_\_\_\_ as Judge for the Knox County General Sessions Court, Division II, to serve the unexpired term of Judge Geoffrey P. Emery was before the Board of Commissioners.

Commissioner Lundy nominated Ms. Sarah Keith. Commissioner Durrett passed. Commissioner Smith nominated Mr. Judson Davis. Commissioner Ward passed. Commissioner Schoonmaker passed. Commissioner Hill nominated Mr. Judson Davis. Commissioner Busler passed. Commissioner Beeler passed. Commissioner Dailey passed. Commissioner Jay passed. Commissioner Biggs passed.

Upon roll call vote Commissioners Smith, Ward, Schoonmaker, Hill, Busler, Beeler, Dailey, Jay and Biggs voted for Mr. Judson Kyle Davis. Commissioners Lundy and Durrett voted for Ms. Sarah Keith.

Mr. Judson Kyle Davis received 9 votes.

Ms. Sarah Keith received 2 votes.

Commissioner Biggs moved to approve R-21-12-101-SS - Consideration of a Resolution of the Commission of Knox County, Tennessee, appointing Mr. Judson Kyle Davis as Judge for the Knox County General Sessions Court, Division II, to serve the unexpired term of Judge Geoffrey P. Emery. Commissioner Schoonmaker seconded the motion and upon roll call vote Commissioners Lundy, Durrett, Smith, Ward, Schoonmaker, Hill, Busler, Beeler, Dailey, Jay, and Biggs voted aye. The motion carried 11-0-0-0.
